- Horse Stalls:** Your entry fee includes one regular horse stall. If you would like to stable in E barn, please indicate below. Spruce Meadows endeavours to assign requested stabling to everyone. However, if it is not possible, a credit will be applied to your horse's account for the difference. If you are coming to Spruce Meadows with a barn, please be sure to check where the rest of your barn is stabling before you fill out your entry to avoid disappointment with the location of your stalls.
- Extra Stalls:** Please include the number of extra stalls needed in the "quantity" column. The number must be the same for the entire series, and must be the same level as the horse stall.
- If stabling with a group, the group must request the same level of stabling.
- You must inform the Tournament Office AT LEAST 36 hours before your arrival. The gates will NOT be open if you are not expected. There is a \$250 fine if your horse is found in an unauthorized stall at any time.
- If you do not select stabling for the Off-Week, and are returning for the 2nd half of circuit, your stalls will not be in the same location and set ups must be fully dismantled.
