

WESTJET – Evening of the Horse Contest

CONTEST RULES (the "Rules")

PROMOTION PERIOD:

The Spruce Meadows ("Spruce Meadows") Evening of the Horse presented by 'WESTJET' promotion (the "Promotion") starts at 9:00 am, MT, Thursday, June 1, 2023, and ends at 23:59 pm MT, Friday, July 28th, 2023 (the "Promotion Period").

ELIGIBLE PARTICIPANTS:

The Promotion is open to any person who is a permanent resident of Canada, excluding Quebec, who is 18 years of age or older and who is not a director, officer or employee of TELUS or Spruce Meadows, its agents or affiliates or any person who is domiciled with any of the foregoing persons.

The entrant will be required to correctly answer, unaided, a time-limited, mathematical skill-testing question, confirm their eligibility and otherwise comply with these Rules before being declared the winner. After completing and returning a declaration and release form, the winner will be sent the prize confirmation letter described above. If a selected entrant fails to correctly answer the skill-testing question, cannot confirm eligibility, cannot be contacted within one week of the selection date or otherwise fails to comply with these Rules, that entrant will be disqualified and another selected.
