Given the current covid-19 situation, please note that the FEI's approval of a Schedule should not be taken as an absolute guarantee that the Event will definitely go ahead. The decision whether the Event can take place must be made by the OC and NF in close consultation with the applicable domestic government and public health authorities. It is the responsibility of each Participant to check the status of the Event prior to planning his/her travel to the Event.



EQUINE BIOSECURITY

The Spruce Meadows Executive and Organizing Committee, in consultation with veterinary and animal health authorities, have determined the protocol deemed necessary in order to reasonably and effectively manage the possible biosecurity concerns. It is STRONGLY recommended that you consult with your veterinarian regarding the most appropriate vaccination protocol for your horse.

All horses brought onto the grounds shall not have been in contact with sick horses within the last 21 days, and must not be showing any signs of illness. All horses on the grounds are required to have their temperatures taken and recorded twice daily through the FEI Horse Health App and/or on the horse's stall on non competition days. Any elevated temperature or other signs of illness must IMMEDIATELY be reported to the FEI veterinary delegate, treating veterinarian and tournament office.

Please avoid direct and/or indirect contact between horses, especially nose-to-nose contact and the use of common feed/water buckets, and individuals handling horses from different barn groups. Individuals should not be entering the barn area of a different group. Please wash/sanitize your hands frequently throughout the day, especially after being in a communal area. Hand sanitizing stations will be located throughout the property.

The Spruce Meadows Executive and Organizing Committee, as well as the Veterinary Commission, will closely monitor any developments regarding any potential biosecurity issues and will change the procedures and requirements for horses entering the grounds as needed.

COGGINS, EQUINE INFLUENZA, & EHV

All horses being brought onto the grounds must have a current NEGATIVE COGGINS TEST (valid for 6 months from date drawn), be in compliance with the FEI requirements for Equine Influenza Vaccination (FEI Veterinary Regulations Article 1003), and proof of the Equine Herpes Virus vaccination (valid for 6 months from the date administered). Vaccines are not accepted if administered within 7 days of arrival to the grounds. Vaccination and coggins records must be received by the tournament office no later than May 16. Vaccinations and coggins must be valid for the full time your horse is on the grounds. The name on all documents must match the horse's name on entry form and FEI passport. Forms completed with horse's barn name will not be accepted. Spruce Meadows must receive all health documents prior to horse arrival.

COVID-19 PROTOCOLS

All individuals receiving accreditation must be fully vaccinated against COVID-19, with a Canadian approved vaccine. Vaccination records will be required prior to being allowed on the grounds or accreditation being issued.

All individuals are required to self-monitor. Anyone with an elevated temperature, or exhibiting signs of illness may not come on to the grounds without first testing for COVID-19 and obtaining a negative result.

Non-medical masks/face coverings, covering the nose and mouth are strongly encouraged when indoors or when social distancing is not possible.

Individuals are strongly encouraged to wash/sanitize their hands frequently throughout the day. Hand sanitizing stations will be located throughout the property.

Regulations surrounding COVID-19 requirements, including but not limited to mandatory masking, temperature checks, and government mandates, may change with little/no notice.

SMOKING/VAPING/CANNABIS

There is a strict NO SMOKING or VAPING policy in all Spruce Meadows buildings, or within 10 feet of any entrance thereof. Competitors are responsible for the actions of all their staff, owners, trainers, etc. Any person caught smoking in a barn or building, or outside an entrance will be assessed a fine of \$250, applied to the horse's account. Further offences may result in being asked to leave the Tournament grounds and a forfeiture of Tournament fees paid. The use of cannabis (including but not limited to smoking) is STRICTLY PROHIBITED on the Spruce Meadows grounds.

BORDER CROSSING & INTERNATIONAL TRAVEL

Spruce Meadows advises all international competitors, especially those trucking, to check with the relevant border authorities (i.e. Canadian Border Services and the Canadian Food Inspection Agency) prior to arrival at the Canadian border. Customs requires that all horses possess a health certificate issued by the official government veterinarian of the country of origin and have an import permit for entry into Canada. Conditions for entry of horses to Canada are as per Canadian government health regulations. Certain horses may need to see a federal vet at the border in order to cross. Appointments are required well in advance. All horses are required by CFIA to have an import permit issued by the Minister of Agriculture of Canada (www.inspection.gc.ca).


Commercial carriers entering Canada are advised to be aware of the eManifest requirements prior to arriving at the border. Information regarding the E-Manifest can be found on the CBSA website (http://www.cbsa-asfc.gc.ca/prog/manif/menu-eng.html). Please contact CBSA directly with any questions pertaining to the eManifest.

International travelers to Canada will be required to be fully vaccinated against COVID-19, either with both doses of a 2 dose regime or a single dose of a 1 dose regime, at least 14 days prior to arrival to the country.

Many travelers to Canada now require an electronic travel authorization (eta) to enter, as well as a negative COVID-19 test taken within 72 hours of the border crossing, and mandatory hotel stays at a government approved location. Please check the Government of Canada website (http://www. cic.gc.ca/english/visit/) for details. All travellers to Canada must fill out the ArriveCAN app within 72 hours prior to arrival.

For departure from Canada and in order to reduce the wait, at the Sweetgrass border crossing, please email or call well in advance (not the night before) of your departure to request an appointment. Horses travelling to the USA within 60 days of arriving from Europe may require additional testing and paperwork to cross the US border. Please plan accordingly.

III. THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

- 1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
- 2. Horses and Athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
- 3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
- 4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
- 5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

VI. INVITATIONS

1. GENERAL

Horses entered in one CSI star level/category may not enter another CSI star level/category at the same Show.

Horses may take part in national Competitions and international Competitions at the same Show only under the following conditions:

- Horses may take part in national Events up to two hours prior to the start of the international Event's Horse Inspection;
- If the national Event includes Competitions after the international Event ends, either on the same day or on the following day(s), horses having taken part in the international Event may take part in national Competitions only, following the conclusion of the international Event.

Invitations

For all Events at which the CSI Invitation Rules apply, a certain percentage of Athletes must be invited in descending order of the Longines Ranking, a certain percentage of Athletes will be home Athletes selected by the host NF and a certain percentage will be Athletes invited by the Organising Committee (OC); the percentages for each invitation group are established for each star level as follows:

Section 1: Compulsory Invitations

Athletes can choose Events for which they wish to receive an information from the Monday eight weeks prior to the week of the Event until midnight GMT on the 4th Sunday prior to the Event.

Section 2: Home Athletes selected by the host NF

Entries for home Athletes in this section must be made through the FEI Entry System between the Monday eight weeks prior to the week of the Event until midnight GMT on the 3rd Wednesday prior to the week of the Event.

Section 3: OC Invitations

Entries in the OC Invitation Quota can be made in the FEI Entry System from the Monday eight weeks prior to the week of the Event up until the closing date for regular entries (the closing date for regular entries cannot be earlier than the 3rd Thursday prior to the week of the Event, and no later than four days prior to the Event) as indicated in the Schedule.

Events for which the Schedule states that overseas air transportation of Horses will be provided/organised by the OC are, for logistical reasons, authorised to establish the closing date for entries at the earliest on the 5th Sunday prior to the event.

Athletes are invited by the Organiser through their National Federation.

One (1) groom per athlete.

Rides may enter the 2^* and 5^*

All athletes understand that to enter and participate in the tournament, they and their team must abide by and follow all government regulations pertaining to travel to and within Canada, and enter the Spruce Meadows grounds, including but not limited to vaccination requirements, pre travel/arrival testing, masking and quarantine requirements. Any testing is at the athlete/NF expense. Failure to comply or to follow the regulations may result in athletes being unable to participate. The OC is not liable for any lost fees or expenses should that be the case. All athletes and members of their parties agree to follow and abide by all Spruce Meadows rules and regulations, including but not limited to liability, code of conduct and laws of the land. Those rules must follow the FEI Rules and this approved schedule, the OC may not add anything which would go against the rules nor inform the athletes of anything going against the rules after the schedule is approved; the laws of the land take precedence.

VII. ENTRIES

- Entries must be made by NFs through the FEI Entry System for all categories of this Event (<u>https://invitation.fei.org/login</u>);

- All Athletes and Horses participating in any International Competition must be registered with the FEI;
- <u>Athletes and/or Horses present at the Event without having been entered through the FEI's</u> <u>Online Entry System will be automatically disqualified unless compelling circumstances</u> <u>warrant otherwise.</u>

Due to entry requirements for certain horses entering Canada and being stabled at Spruce Meadows, the OC must receive a list of all horses, their status for entering Canada, and the arrival date into Canada no later than August 4. If the information is received late it may affect their ability to enter the country and be stabled on the grounds. The processing time for import permits into Canada is slow, and may not be received in time if applied for late.

3. NO-SHOWS/LATE WITHDRAWALS

NB: In the case of withdrawals after the date of definite entries or no-shows the athlete or the respective NF will be held liable to reimburse the OC for the actual financial loss incurred by the OC (please refer to Jumping Rules Art. 251.17) as a result of the late withdrawal or no-show.

Amount charged: \$1,000 plus extra stalls, paddocks, and/or pre-ordered Cavalor feed, if applicable.

Golf carts are not availabile for rent through the OC. Personal golf carts or those rented from a 3rd party are permitted on the grounds. Please refrain from renting quads.

All individuals wishing to be accredited must provide proof of being fully vaccinated by a Canadian Government approved vaccine or provide proof of legitimate medical exemption prior to arrival. Negative tests/notes of previous infection are not accepted.

Late entries and substitutions/changes made after the definite date may be accepted at the discretion of the Organizing Committee and late fees will apply. Attendees may be required to wear masks while on the grounds. Regulations surrounding COVID-19 and other biosecurity protocols may change with little/no notice. Spruce Meadows will change protocols regarding COVID-19 and biosecurity based on the recommendation / requirement of the local, provincial, or federal governments and/or veterinarians.

Payment in full must be received by the OC by the definite date. If a balance is owed to the OC at the end of the tournament, the balance must be paid prior to the passport being returned. If the athlete would like any credit paid via a wire, please provide the OC with the correct wiring information by the final day of competition.

If your horse is withdrawn from the FEI entry system you must inform the OC if the horse is still coming as a non-competing horse or if it is a full scratch and no long attending. Stabling will not be availabile for non-competing horses without prior arrangement.

VIII. TIMETABLE

<u>Competitions must not start before 08:00 and must not finish after 23:00, unless prior</u> <u>approval is granted by the FEI.</u>

As per Jumping Rules Annex VI: combined competitions are not permitted.

(At Events where the Schedule indicates that the height of obstacles in a qualifying Competition, e.g. the Grand Prix at a CSI3*, is 1.50 m, a special mention may be added to the Event Schedule that if the Competition is listed as a qualifying Competition for the Olympic Games, the World or Continental Championship, the compulsory two verticals at 1.60 m will be included in the course without it being considered to be a Competition conducted at a height of 1.60 m.)

The Course Designer must clearly identify on the course plan of the Competition the specific obstacles that must be included as per the mandatory requirements below, e.g. planks, wall, gate, narrow obstacle, etc.

Mandatory requirements:

- The first obstacle must be either a vertical minimum height 1.45 m or an oxer minimum height 1.40 m for the front pole and 1.45 m for the back pole;
- At least three of the following five obstacles must be included in the course:
- One set of planks on flat cups or a vertical of poles with a plank on flat cups as the top element;
- Triple bar minimum 1.80 m spread and 1.50 m height;



- One wall or gate;
- One narrow vertical or spread obstacle with frontal width between 2m50 to 3m00;
- Minimum one triple and one double combination (three doubles are not allowed);
- The triple combination must have at least one oxer minimum 1m50 height and 1m50 spread, and at least one one-stride distance either from A to B or from B to C;
- Approximately 50% of the efforts must be vertical obstacles and 50% must be spread obstacles (e.g. oxer, triple bar, Swedish oxer, narrow oxer etc.). Nevertheless, no more than 55% of the efforts may be vertical and no more than 60% of the efforts may be spread obstacles, including the water jump if there is one (NB: a water jump is compulsory in Nations Cup Competitions, refer to JRs Art. 264.3);
- Two verticals (other than the wall) must have a height of 1.60 m; *
- At least two spread obstacles with minimum height of 1.50 m and minimum spread of 1.60 m; *
- Two liverpool obstacles, one vertical and one spread. If the course includes a water jump, a minimum of one liverpool will be allowed;
- Bend or straight line of up to six strides between two single obstacles;
- Depth of cups: minimum 50% of cups must have a depth of 18mm, for special obstacle material cups may be shallower (refer to JRs Art. 208.6); depth of cups maximum 20mm;
- Minimum length of course 400 meters with a minimum speed of 375m/min;
- The course will include minimum 12 and maximum 14 obstacles which may vary in height between 1.40 m and 1.60 m;
- At least two of the following recommended criteria must be included in the course:
- One line between two obstacles should be a forward line up to five strides;
- One bend or straight line up to seven strides with minimum three obstacles;
- Double combination in a bend or straight line with an obstacle before or after at maximum seven strides;
- A related distance bend or straight line of up to eight strides leading to the triple combination or up to seven strides following the triple combination;
- One of the combinations must have a related distance (maximum seven strides) with an obstacle (before or after the combination) in a straight line.

* For Nations Cup Competitions at selected CSIO3* and CSIO4* Events, the above requirements relating to the compulsory two verticals of 1.60 m and two spread obstacles with a minimum height/spread of 1.50/1.60 m, take precedence over the requirement established in JRs. The Chief Steward will check that the advertising on athletes and horses complies with these Articles.

Competitors wishing to import goods into Canada are solely responsible for ALL costs associated with the import. The OC is not liable nor responsible for any such costs.

2. HEALTH REQUIREMENTS

GENERAL

In accordance with the FEI Code of Conduct for the Welfare of the Horse it is imperative that all Horses at FEI Events are physically fit and free from infectious disease before being allowed to compete.

ENTRY OF HORSES

Required health tests and vaccinations: EHV vaccination within 6 months but not within 7 days of arrival to the grounds. Equine Influenza vaccination as per FEI regulations. Negative coggins test pulled within 6 months. All negative coggins/vaccines must be valid for the duration of the horse's stay on the grounds, and copies must be received prior to arrival. Horses will not be admitted into FEI stabling until proof has been received. Extra charges will apply if the information is not received on time.

Quarantine period: Permanent import quarantine is not available on the grounds. Temporary or returning quarantine requests need to be submitted by August 4 and are not guaranteed. If arrangements have not previously been made, all horses must be cleared from quarantine before arriving onto the Spruce Meadows grounds. Horses arriving on different health papers will not be able to be accomodated in the same barn as other health status' in the same group. Horses entering Canada on temporary import permits are NOT ALLOWED to leave the Spruce Meadows grounds unless under a VD/VSM/PTV directed veterinary emergency, or unless another venue is listed on their import permit, as per the Government of Canada. Those who do not comply will not be eligible to return to the Spruce Meadows grounds. The OC is not liable for any lost entry fees or other costs in this scenario. Specimen Import Licence applied:

For questions or problems, please contact your Government Veterinary Services.

Arrivals: The athlete/groom/PR must contact the OC at least 36 hours in advance of estimated arrival to inform the OC of the approximate arrival time and border appointment time (if applicable). Late/no notice of arrival will results in additional fees. Horses must be on the grounds by 5pm on Tuesday August 30 unless previous arrangements have been made. Horses wanting to arrive prior to 9am and after 5pm will be charged an "off-hours" arrival fee, and may have to unload into a temporary stabling location until a vet is available. Horses may not move in to FEI stabling

without first being seen by the FEI veterinary delegate or treating veterinarian. Limited isolation stabling outside of the FEI stabling area may be available. Extra stabling, bedding, and sanitation charges will apply. Please plan your arrivals carefully and keep us informed of any unexpected delays. Horses must have their temperatures entered in the FEI Horse Health App for 3 days prior to arrival.

3. NATIONAL REQUIREMENTS

Please see www.inspection.gc.ca for more information on national entry requirements from your point of origin. At this time mandatory pre arrival COVID and possible on arrival testing and a quarantine plan in the event of a positive test are required to enter Canada. Spruce Meadows is unable to assist in the event there is a problem with your COVID paperwork..

4. PONIES

FEI Veterinary Regulations, Chapter IX and Annex IX: For all Pony Events, Ponies must be available for Pony Measurement if requested by the FEI.

5. INJURY SURVEILLANCE

FEI Veterinary Regulations, Chapter VIII:

Horses participating in FEI Events are subject to injury surveillance protocols; and in the event of fatality, a post mortem examination.

6. TRANSPORT OF HORSES

Horses must be fit to travel and be transported in suitable vehicles for the transport of horses. Any government requirements for disease testing and control must be requested well in advance, to ensure that the horse is in compliance by the time of arrival at the border of the country where the Event is taking place. Athletes, or their representatives, have the responsibility to comply with national legislation in both their country of origin and the host nation of the Event. Where necessary athletes must contact local government authorities or veterinary advisors for information regarding animal health requirements and transport legislation. Within the European Union (EU), this includes EU Council Regulation (EC) No 1/2005 concerning the protection of animals during transport within the Member States of the EU.

7. VENUE ARRIVAL INFORMATION & FITNESS TO COMPETE

7.1. PASSPORTS. FEI General Regulations, Art. 137

For all issues relating to FEI Horse Passports/FEI Recognition Cards please contact your National Federation.

All Horses competing at FEI Events must be registered with the FEI.

FEI Passports or FEI Recognition Cards (for those Horses with a national passport approved by the FEI) are compulsory for FEI Events.

NB: Horses entered in CIMs and in CSIP in their country of residence are not required to have an FEI Passport or FEI Recognition Card but must be properly registered with the FEI and identifiable (FEI General Regulations, Art. 137.2). Athletes who do not present a Horse's Passport and/or Recognition Card, or one that is not correctly validated or fail to meet other passport requirements will be **subject to Sanctions** in accordance with Annex VI of the FEI Veterinary Regulations and may not be allowed to compete.

NB for Horses permanently resident in a Member State of the European Union: all Horses must have a national EU passport in compliance with EU Regulations to which a FEI Recognition card is applied. The exception to this being Horses in possession of an FEI passport which has been continually revalidated without interruption.

7.2. VACCINATIONS - EQUINE INFLUENZA. FEI Veterinary Regulations, Art. 1003

Horses competing at FEI Events must comply with the requirements for Equine Influenza vaccination in accordance with the Veterinary Regulations and as summarised below.

All FEI registered Horses intending to compete at FEI Events (including CIMs) must be vaccinated against Equine Influenza in accordance with these VRs. The exception being if the applicable domestic legislation prevents the use of Equine Influenza vaccines within the relevant territory

7.3. EXAMINATION ON ARRIVAL. FEI Veterinary Regulations, Art. 1031

On arrival at an Event venue, all Horses must undergo an examination by a veterinarian to confirm their identification from their passport and micro-chip ID (where present), their vaccination status and general health. To protect all horses attending events, any Horse with a questionable health status concerning vaccination, disease or other concerns, must be stabled within the isolation facilities provided by the Organising Committee pending a decision on entering the venue. PRs must fulfil the Horse Health Requirements via the FEI HorseApp in advance of the event which will be checked at the Examination on Arrival.

7.4. HORSE INSPECTIONS. FEI Veterinary Regulations, Art. 1034-1042

All Horses will be assessed for their fitness to compete during the Horse Inspection. Any Horse demonstrating questionable fitness may be referred to the Holding Box for further veterinary examination. Horses not deemed fit to compete by the Inspection Panel will not be permitted to compete.

7.5. LIMB SENSITIVITY EXAMINATION. FEI Veterinary Regulations, Art. 1048-1053 and Annex VIII

All Horses are subject to examination under the protocol for abnormal limb sensitivity throughout the period of an Event. For Jumping that includes, but is not limited to, between rounds and before the Jump Off. Horses may be examined once or on multiple occasions during the Period of an Event.

Horses may be selected for examination under the protocol randomly or they may be targeted. All Horses selected to be tested must submit promptly to the examination or are subject to immediate disqualification. There is no obligation to examine any specific number of Horses at an Event.

8. EQUINE ANTI-DOPING AND CONTROLLED MEDICATION PROGRAMME (EADCMP). FEI VETERINARY REGULATIONS, CHAPTER VII

8.1. SAMPLING. FEI Veterinary Regulations, Chapter VII

All horses competing at FEI Events may be subject to sampling for the presence of Prohibited Substances in accordance with the Anti-Doping and Controlled Medication Regulations (EADCMRs). Horses may be selected for sampling in accordance with obligatory testing, targeted or random sampling procedures. Refer to FEI Financial Charges for details of fees relating to Equine and Human Anti-Doping program (EADCMP), which OCs/NFs have the right to charge to the athlete (applicable for all FEI events worldwide).

8.2. ELECTIVE TESTING. FEI VETERINARY REGULATIONS ARTICLES 1058

Elective Testing may be carried out prior to an Event to check for the presence of Prohibited Substances. Please refer to <u>https://inside.fei.org/fei/cleansport/horses</u> for information and details.

XIII. HUMAN ANTI-DOPING

Athletes can be tested at any FEI Event, by the FEI or by other Anti-Doping Organisations with Testing jurisdiction. Organisers will have the responsibility to provide facilities and staff/volunteers to facilitate such Testing if requested by the FEI as outlined in article 22.3 of the FEI's Anti-doping Rules for Human Athletes (ADRHA).

The ADRHA rules are published on the FEI website at <u>http://inside.fei.org/content/anti-doping-rules</u>.

XIV. ADDITIONAL INFORMATION

1. THE FEI POLICY FOR ENHANCED COMPETITION SAFETY DURING THE COVID-19 PANDEMIC

The FEI Policy for Enhanced Competition Safety during the Covid-19 Pandemic ("Policy") (<u>https://inside.fei.org/system/files/FEI%20Policy%20for%20Enhanced%20Competition%2</u> <u>OSafety%20during%20the%20Covid-19%20Pandemic%20-</u>

<u>%20Effective%201%20July%202020%20-%20Updated%2012%20October%202020.pdf</u>) is mandatory and applies for any FEI Event taking place **as of 1 July 2020**. The Policy has been developed based on currently accepted best practices by the WHO and US Center for Disease Control (CDC) and will be continually reviewed and updated as more information becomes available. It is not intended to replace the applicable guidance and policies from domestic government and health authorities, but to supplement their recommendations with sport specific considerations.

The OC shall submit the risk assessment and mitigation plan (including name and contact details of the person in charge) to the FEI as an annex to the Event Schedule, at <u>the latest</u> ten (10) working days before the event's deadline for Definite Entries.

Events for which the FEI has not received the documented risk assessment and mitigation measures plan in accordance with article 2.1.g) of the Policy **will be removed from the FEI calendar** in accordance with Article 112.3 of the FEI General Regulations.

ASSUMPTION OF RISK / WAIVER OF LIABILITY

In consideration of being allowed to participate in the Event and related activities, all Participants (as defined in the Policy) acknowledge, appreciate, and agree that:

- 1. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
- 2. The Participants knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the OC or others, and assume full responsibility for their participation; and,
- 3. The Participants willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, a Participant observes any unusual or significant hazard during his/her presence or participation, the Participant will remove himself/herself from participation and bring such to the attention of the nearest official immediately; and,
- 4. The Participants, for themselves and on behalf of their heirs, assigns, personal

representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS THE OC AND THE FEI, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

The Participants confirm to have read this release of liability and assumption of risk agreement, fully understand its terms, understand that they have given up substantial rights.

2. INSURANCES AND NATIONAL REQUIREMENTS

Equestrian sports involve inherent dangerous risks. To the greatest extent permitted by law, the FEI and the FEI Event Organiser shall NOT be liable for any damages relating to loss of property or injury of any kind to Athletes, Owners, Support Personnel or Horses at or in connection with an FEI Event and the FEI expressly excludes all such liability.

2.1. ATHLETES, OWNERS AND SUPPORT PERSONNEL

2.1.1. Personal Accident and Health Insurance

It is your responsibility as an Athlete/Owner/ Support Personnel to ensure that you have adequate personal accident insurance in place to cover your participation at FEI Events and in particular to insure against any personal injury or medical expenses arising from an accident, injury or illness which may occur at a FEI Event.

You should check with your National Federation to confirm if your National Federation's insurance policy (if any) covers personal accidents and/or illnesses which may occur when you are attending/participating in FEI Events.

If your National Federation does not have a personal accident/health insurance policy or if the National Federation's insurance policy does not cover personal accident or health claims, then you should obtain your own personal accident and health insurance policy to cover your attendance/participation at FEI Events.

2.1.2. Personal Property Insurance

You should also ensure that you are insured against property loss, theft or damage which may occur at an FEI Event.

Again, the advice is to check with your National Federation to confirm if they have an insurance policy in place which would cover you in case of such property loss, theft or damage. If not, then you should obtain your own personal property insurance to cover such situations.

2.1.3. Press Equipment

Press equipment and other items left in the Press workroom, Press lockers, the Press Tribune or anywhere on the showgrounds are left entirely at the owner's risk. The Organising Committee does not accept any responsibility for any loss or damage to such equipment or items. Members of the Press are advised not to leave any equipment or personal items unattended.

2.2. ATHLETES AND OWNERS

2.2.1. Third Party Liability Insurance

As an Athlete/Owner you are personally responsible for damages to third parties caused by you, your employees, Support Personnel, your agents or your Horses. You are, therefore, strongly advised to take out third-party liability insurance providing full coverage in relation to FEI Events at home and abroad, and to keep the policy up to date.

The FEI and the Organiser will NOT be responsible for any damage caused to third parties by you, your employees, Support Personnel, your agents or your Horses.

2.2.2. Additional Liability Information

2.2.3. Horse Insurance

As an Owner you should ensure that your Horses are adequately insured against any injuries or illnesses they may sustain while participating at a FEI Event.

Spruce Meadows is not responsible nor liable should the appropriate insurance not be in place in advance of the event. Insurance is not available through Spruce Meadows.

3. PROTESTS/APPEALS

To be valid, all Protests and Appeals must be made in writing and accompanied by a deposit of CHF 150.- or equivalent, as mentioned in the FEI General Regulations (Art. 161-162) available at the following link:

4. SCHOOLING DURING COMPETITIONS

Athletes wishing to school during speed competitions (Table A and Table C) must inform the OC before these competitions begin. These athletes will start first in these competitions.

5. STEWARDING

- If an athlete is uncertain as to whether the boots they intends to use during an event are allowed, they or their representative should show the boots to the Chief Steward for their opinion before the boots are used in training or in competition.
- In addition, athletes are to be made aware that hind boots must be removed and placed again on the horse's legs in the presence of a Steward while in the warm-up arena prior to entering the competition arena for certain competitions. (If bandages are used in place of boots, athletes are not required to remove the bandages in the warm-up arena.) This procedure is compulsory for competitions for which boot and bandage control is mandatory, that is the Nations Cup, Grand Prix, and the competition with the highest prize money, and is at the discretion of the Chief Steward for other competitions.

- As an alternative to carrying out this procedure at the time designated by the Steward an athlete may ask their groom to take the boots to the in-gate and place them on the horse's legs in front of the Steward prior to the combination entering the arena.
- The Steward has the authority to intervene if a boot is deemed excessively tight by instructing that the boot be removed and put on again correctly. [Stewards are to note that it is normal for a horse's gait to be somewhat affected immediately after boots have been removed and re-placed.] If an athlete or his/her groom refuses to remove and re-place the boot(s) when instructed to do so by the Steward, a Yellow Warning Card will be issued to the athlete in question.
- If it is deemed impossible or unsafe to remove the hind boots in the warm-up arena prior to the combination entering the competition arena, due to an extremely excited or nervous horse, the boots of the horse in question are to be removed by the athlete/groom following the athlete's round upon leaving the arena and inspected by the Steward. This inspection may be carried out during the boot and bandage control if the boot and bandage control is carried out for the competition in question.
- This procedure does not replace boot and bandage control after completion of an athlete's round for competitions for which boot and bandage control is mandatory (refer to JRs Art. 244.1).

6. DISPUTES

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the English version will be decisive.

7. MODIFICATION TO SCHEDULE

In exceptional circumstances, together with the approval of Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the Organiser may change the schedule in order to clarify any matter arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the Technical Delegate, the President of the Ground Jury or the Foreign Judge, as applicable.

In case of a tie for the 12th place in a competition with 12 to 48 starters, the prize money foreseen for the 12th place will be divided equally among the athletes concerned.

For Competitions run in two rounds with more than 12 starters in 2nd round:

OCs that indicate in the schedule that a specific number (that is more than 12) of athletes will return for the second round will be permitted to distribute the prize money for that competition among all the athletes taking part in the second round, even if the second round is followed by a jump-off in case of a tie on penalties for first place after the second round.

DEDUCTIONS FROM PRIZE MONEY AT COMPETITIONS:

Full details of any deductions from prize money must be outlined in the schedule. This includes government taxes. If it is necessary for Organisers to deduct such taxes, they <u>must</u> provide participants with an official form indicating the amount of tax deducted.

The tax form must be provided to the athletes upon arrival and returned to the Organiser prior to departing.

It must be declared by the definite date to whom the prize money is to be paid (owner/lesee or Athlete). If no declaration is made, the prize money will be paid to the owner as listed on the FEI website. Revenue Canada Tax Department requires in the payment of funds to Foreign Competitiors and/or Foreign Owned Horses (in whole or in part) who are non residents of Canada, 15% of each payment must be withheld and submitted to the Canadian Tax Department. A T4A-NR form will be emailed from Spruce Meadows by February 28, 2023, in the name of declaree of prize money, so that it can be included in the competitor/owner 2022 tax return. Spruce Meadows is unable to change the name to which the T4A-NR after it is issued. An explanatory letter will be given to competitors upon close-out of the tournament or sent with their T4A-NR form. Canadian residents/Canadian tax payers/companies must submit a business/tax id prior to the start of competition to be exempt from withholding tax.

IMPORTANT

<u>The total amount of prize money shown for each Competition in the schedule must</u> <u>be distributed</u>. (FEI General Regulations articles 127 and 128)

For details of the prize money breakdown for each competition please refer to the tables at the end of this document; the Organiser must specify which of the two (2) tables will be used. The total prize money for the Competition must be distributed among the first twelve (12) placed athletes.

The Organiser must provide additional created prizes for athletes placed beyond twelfth (12th) place. The minimum amount for each of these additional prizes, for athletes placed from thirteenth (13th) to last place, must be clearly specified in the approved schedule and not exceed the prize money of the athlete placed twelfth (12th)

10.MAXIMUM NUMBER OF STARTERS PER COMPETITION

*Annex VI FEI Jumping Rules:

Maximum 100 starters per Competition other than the GP. If more than 100 starters are declared, the OC must split the Competition into the number of groups required to ensure that there are no more than 100 starters in any group, and provide the same amount of prize money as indicated for the original Competition for each group. The additional prize money provided by the OC is not taken into consideration with regard to the overall prize money that determines the star level of the Event or the Longines Ranking point group of the Competition, if applicable.

OCs may apply either of the following methods for splitting the Competition:

The competition is split into the number of groups required before it starts. There may be athletes with multiple horses in each group but all horses of any one athlete must be in the same group. If it is not possible to have groups of equal size there may be a different number of starters in each group;

OR

The competition is run as one single competition and split afterward into the number of groups required to ensure that there are no more than 100 starters in any group, and the classification established as follows: the athlete with the best score is the winner of the first group, the athlete with the second best score is the winner of the second group and so on until prizes have been allocated to 25% of the total number of starters. *NB: In this case separate results must be sent to the FEI for each of the groups, e.g. results for Competition 1a and for Competition 1b (and for Competition 1c if the original Competition was split into three groups, etc).*

In both cases above each group must offer the same amount of prize money as indicated for the original Competition. For the avoidance of doubt, it is the number of declared starters in the Competition, not the final number of starters that determines whether the Competition must be split.

As all FEI World Cup[™] Competitions have the status of a Grand Prix, the minimum prize money requirements for the Grand Prix are applicable to the FEI World Cup[™] Competition. For CSI-W Events with a Grand Prix Competition in addition to the FEI World Cup[™] Competition, the minimum prize money requirements for the Grand Prix apply only to the FEI World Cup[™] Competition; the Grand Prix Competition at such Events cannot offer more prize money than the prize money offered for the FEI World Cup[™] Competition.

11. GLOSSARY

*Glossary FEI Jumping Rules:

Fees:

- Compulsory Fee: Compulsory Fees are fees that may be charged by the OC for costs/services not included in the Entry Fee. Compulsory Fees, if charged, must be paid by the Athletes concerned as outlined below. Only the following Compulsory Fees may be charged by the OC, providing full details of the amount to be charged is included in the Schedule and approved by the FEI:
 - NF fee if applicable
 - NF medication control programme fee if applicable
 - FEI EADCMR fee if applicable (OC to indicate in the Schedule if the EADCMR fee is included in the Entry Fee or not)
 - Fee for health/customs-related documents for Horses if these have been requested by the Athlete.
 - Fee for manure disposal (maximum € 40 per horse per Event)
 - Fee for lorry parking if applicable (The fee indicated in the Schedule may only be charged per lorry not per Athlete.)
 - Fee for electric hook-up for lorry (The fee indicated in the Schedule may only be charged per lorry, not per Athlete.)
- Discretionary Fee: Discretionary Fees are fees that may be charged for optional commodities/services that may be purchased by an Athlete if he so chooses and that do not affect the equity of the Athlete's right to compete at the Event or the well-being of the Horse, such as:
 - VIP or premium parking
 - VIP table
 - Extra box for tack or for non-competing Horse
 - Extra bedding and/or fodder (details to be included e.g. shavings, straw, hay)
 - Premium stabling (all stabling at the Event must meet minimum FEI requirements)
- Entry Fee: The Entry Fee is the fee charged to participate in an Event with one Horse and covers the following:
 - Stabling of one Horse for the duration of the Event (includes cleaning and disinfecting stables before the event, including between Events that are part of Tours, water and electricity in the stables, first bedding or a fixed amount of bedding depending on the type of event and 24 hour security services for the stables)

- Use of all facilities at the Event (no infrastructure fees may be charged)
- Right to participate in all Competitions in accordance with the conditions in the Schedule (no nomination fees or start fees may be charged)
- Administrative/Office fees (includes all services relating to administration of the Event and running of the Competitions: data/results/timing services, bookkeeping and accreditation services)
