# **WestJet Evening of the Horse Contest**

## **OFFICIAL CONTEST RULES (the "Contest Rules")**

## **CONTEST PERIOD:**

The WestJet Evening of the Horse Contest is presented by Spruce Meadows Ltd., herein referred to as the "Sponsor", and starts at 9:00 am MT on July 7<sup>th</sup>, 2025, and ends at 11:59 pm MT on August 7<sup>th</sup>, 2025 (the "Contest Period").

## **ELIGIBLE PARTICIPANTS:**

## WESTJET FLIGHT TERMS AND CONDITIONS

The selected entrant will then be asked to provide their email address for further communication. The entrant will be required to correctly answer, unaided, a time-limited mathematical skill-testing question, confirm their eligibility, and otherwise comply with these Rules before being declared the winner.
