All horses must have the following to come on to the Spruce Meadows grounds:

- Equine Influenza and EHV vaccinations given within 6 months +21 days (and not within 7 days of arrival to the grounds)
- Negative coggins test drawn within the last 6 months.

The horse name on all health documents must match the name under which the horse has been entered. Coggins/vaccines must be valid for the full time the horse is on the grounds.

Your entry form is considered **INVALID** if not accompanied by **FULL PAYMENT**.

If your entry form is received without full payment, your horse will be assessed a late fee of \$125 and will be subject to the approval of the Organizing Committee. Declined Credit Cards will be subject to a \$75 fee.
