FEI entries are based on the Invitation system; acceptance is not guaranteed. **YOU MUST BE ENTERED & ACCEPTED IN THE FEI ENTRY SYSTEM TO COMPETE.**

You must submit the entry form IN ADDITION to being added in the FEI entry system. Please contact your Federation to ensure you are entered properly by the deadline. As per FEI Article 116, all FEI entries must be made through the FEI entry system.

Canadian Athletes - you do NOT need to contact your federation. You will be entered in the FEI entry system based on the information provided here. If there are any changes to your entry, please contact Spruce Meadows directly.

Your horse must be nominated in at least one division per week and pay the associated mandatory fees to be accepted into the series.

STABLING INFORMATION

- Horse Stalls:** FEI and Non-competing entries include one regular horse stall per competition week. Please indicate if you would like to stable in E barn (10x12 stalls). Priority in E barn will be given to circuit horses. If this horse is travelling with an FEI horse and you would like them stabled together, check off "Accompanying FEI". Subject to availability and admissibility. Spruce Meadows endeavours to assign requested stabling however if it is not possible, a credit will be applied to your horse's account for the difference.
- If you have entered FEI for part of a Tour, you will be stabled FEI for the full Tour unless otherwise stated.
- Extra Stalls:** The number must be the same for the all weeks of the tour, and must be the same level as the horse stall.
- If stabling with a group, the group must request the same level of stabling.
- You must inform the Tournament Office AT LEAST 48 hours before your arrival. The gates will NOT be open if you are not expected. There is a \$250 fine if your horse is found in an unauthorized stall at any time.
- If you do not select stabling for the Off-Week, and are returning for the 2nd Tour, your stalls will not be in the same location and set ups must be fully dismantled.

A \$950 no-show fee per week (plus any extra or off week stalls and pre-ordered feed) will be charged for horses entered in the FEI entry system that do not compete, or are withdrawn after the definite date. Horses withdrawn out of the FEI entry system after the definite date are responsible for both the late withdraw fee IN ADDITION to any EC competition/non-competing fees.
